• Parking Lot Safety

Curtis Stoltz reminded members to be cautious in the parking lot due to equipment and potential hazards like nails.

Camera Surveillance

Michael Marcello updated on the camera surveillance system and signage, inviting members to ask questions or visit to see the camera placements.

• Parliamentarian Vacancy

The club currently has no parliamentarian, and efforts to fill the position will continue into the new year.

Bylaws and Constitution Changes

Bob Barton made a motion to amend the Club's Constitution in Article VII Section 5. The duties of the Treasurer. Paragraph c. currently reads: "To make an annual report in writing at the Annual Meeting, reporting the year's total receipts and disbursements and the total of money in Club accounts." Bob moved that Paragraph c. be amended to the following: "To report in writing at the January Board and regular meetings the total of money in Club accounts on December 31 of the year just ended, AND that year's receipts and disbursements compared to budget." This motion was seconded by Eric Phillips and will be voted on at the December Annual Meeting.

- Bob also made a motion to amend the Club's Bylaws in Chapter 9: Financial Reporting. After some brief discussion, Donna Kart proposed to table this motion until the next meeting to allow Bob make refinements. Her proposal was seconded and unanimously approved.
